- I agree to maintain a credit rating that is acceptable to my creditors, suppliers, and subcontractors which conforms to the generally accepted practice in the industry. If I have employees, I agree to carry workers' compensation insurance as required by the laws of Pennsylvania; and I agree to carry a proper amount of liability and property insurance as required by Pennsylvania Law.
- Under Pennsylvania Home Improvement Consumer Protection Act (www.attorneygeneral.gov) , I will provide my registration number to the Carbon Builders Association.
